3. Technology Dependent Waiver Updates/Interim Session

- Gina discussed the technology-dependent waiver, highlighting efforts to secure services for adults with complex needs, and mentioned potential legislative support. During the interim session, Tina Persels testified on the shortfalls of the tech dependent waiver and the need for increased access to services within the waiver.

4. Roundtable

- The group addressed concerns about Medicaid cuts, including immunization access for vulnerable populations.
- Stacy discussed healthcare tax credits and shared information about collecting narratives from those affected (please see the attached flier).
- Cheryl provided updates on the efforts to expand the Carson Smith Opportunity Scholarship and increase funding for adult autism treatment.
- Jennifer shared that ballots for the municipal election will be available starting October 14th (General Election on November 4th, 2025) and both major parties are hosting their 2026 Neighborhood Organizing Caucus Night March 17th, 2026.

- The group discussed funding differences between various Medicaid waivers, with Mary Ann explaining that the limited supports waiver provides a middle ground for individuals with moderate needs who might otherwise languish on waitlists.
- Marian raised concerns about potential tariffs on imported drugs, particularly affecting medications like immune globulin products, and Janet suggested contacting congressional representatives for assistance.
- Tammy Hodson mentioned that the House Health and Human Services Committee has new leadership (Chair and Vice Chair) and are providing information and seeking input on Medicaid/healthcare concerns through a new podcast:
